

AN INTERGOVERNMENTAL AGREEMENT TO PROVIDE RECIPROCITY OF
AMBULANCE LICENSING BY THE COLORADO COUNTIES OF BACA, BENT,
CROWLEY, KIOWA, OTERO, AND PROWERS

AGREEMENT entered into the day and year hereinafter set forth by the Counties of
Baca, Bent, Crowley, Kiowa, Otero and Prowers in the State of Colorado,

Recitals

The parties hereto wish to enter into an agreement providing for reciprocity of
ambulance licensing in their respective Counties, which is intended to provide to the
citizens of each County emergency medical and trauma services, and

This Agreement among said Counties is entered into pursuant to Article XIV,
Section 18 of the Colorado Constitution and C.R.S. 29-1-203, which provisions provide for
government entities to cooperate and contract with one another to provide any lawful
governmental function or service, and

This Agreement is also entered into pursuant to the provisions of the Colorado
Emergency Medical and Trauma Services Act, C.R.S. 25-3.5-101 et seq.,

NOW THEREFORE, the parties hereto agree as follows:

1. Reciprocal Licensing. The parties agree that a license issued to an ambulance
provider by the County in which the ambulance service is based shall be accepted as valid in
the other Counties which are parties to this Agreement. Each County shall accept the
licensing and inspection procedures as valid as conducted by another County. Each County
will grant to such ambulance service reciprocity for the validity of such licensing and
ambulance inspection by another County. This will avoid duplication of such licensing and
inspection procedures and avoid unnecessary expense for ambulance providers.
2. Proof of Licensing. Each County shall provide notice to the other Counties of
licenses issued to ambulance services which are based in that County. Each County agrees
to maintain a current list of ambulance service licensees so that the other Counties which
are parties to this Agreement will be advised of which licensees are entitled to reciprocity
under this Agreement.
3. Multi-County Licensing. This reciprocity agreement is intended to apply to
ambulance services which are based in one County, but from time to time are engaged in
mutual aid calls and normal transport runs to and from the County in which the ambulance
service is based. However, if an ambulance service wishes to do business and be based in
more than one County, then such ambulance service provider shall be required to obtain
approval from and be licensed in each County in which such provider is based.

4. Term of Agreement. This Agreement shall be valid when approved by all parties to this Agreement, and shall be valid through December 31, 2015. This Agreement shall be automatically renewed on an annual basis. However, any County reserves the right to terminate this Agreement at any time by providing notice of termination to the other Counties upon not less than 30 days prior written notice.

5. Miscellaneous. This Agreement is intended to benefit each County which is a party to this Agreement. There is no private cause of action under this Agreement. No County will be obligated to provide indemnity to any other County. Each County reserves governmental immunity as provided by law. In the event of a public records demand pursuant to the Colorado Open Records Act, the Counties shall cooperate in providing a response to such request. This Agreement may not be assigned by any party to another party without the written consent of all parties to this Agreement. This Agreement shall be interpreted under the laws of the State of Colorado.

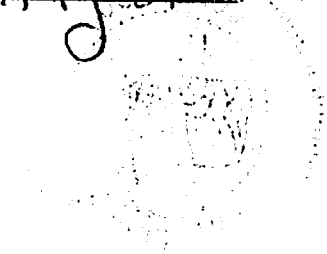


